Rent Collection Fees

Proposed at 6% + VAT on monthly rent collected;

Tenant Finder's Fees (TFF)

This will be charged at 50% + VAT of the value of the first month's rent. No additional TFF is payable during the first year of tenancy, whether or not the premises is occupied by more than that one tenant for the next 12 months from the date of entry of the initial tenant.

Disbursement Advances

Appropriated between Kes 1,750/= and Kes 2,500/= Based on apartment size, service is optional and the advances are intended for disbursement to supplier invoices:

Surplus/ deficit adjustments will be done annually

Administrative Fees

IV. Preparation of tax returns for monthly rent income (MRI) relating to the property.
